2. Design

Design

The brand should represent the Transport
Scotland organisation loosely, but in terms of look
and feel we need to be a lot braver with our design
than that of the current Transport Scotland
website.

NOTE: Due to organisational red tape the TSRSP website will be found by accessing the Road Safety Scotland website, and NOT the Transport Scotland website. It's envisage a prominent link in the main or eyebrow navigation will link the user through to the TSRSP website as conveyed further on in the brief.

The Transport Scotland website is very much seen as being a boring and corporate facing website, whereas the TSRSP team want their website to be full of engaging, sharable, interactive, highly styled, visually appealing contentnot just full of PDF's and thousands of words on a page on a corporate website.

We have to create a unique style that can be carried across all additional online communications – the animation style will shed some light on the work we've done for them so far.

Brand guidelines have been included, but we're not expecting you to use them religiously, and you also have the creative freedom to use a variety of different accent colours as you see fit on the website.

The website needs to be bold - their vision is bold, and they want to people to visit the website and start a conversation about Road Safety in Scotland - no fatalities or serious injuries are acceptable.

3. Background

Transport Scotland has four road safety teams:

Road Safety Policy, Road Safety Scotland, Strategic Road Safety, and Safety Camera Programme teams.

The Transport Scotland Road Safety Policy (TSRSP) team is responsible for helping to ensure the delivery of the commitments contained in <u>Scotland's Road Safety Framework</u> to 2020, in partnership with other key stakeholders – they could easily change the name of their organisation from TSRSP to the Road Safety Framework team.

Scotland's road safety vision is that there will be:

A steady reduction in the numbers of those killed and those seriously injured, with the ultimate vision of a future where no-one is killed on Scotland's roads, and the injury rate is much reduced.

The above is a bold statement, therefore the website needs to be bold in its offering.

4. Purpose & Objectives

The Gate have been asked to:

Work with the TSRSP team to undertake user research in order to inform a scalable site structure, identify content and functional requirements in order to finally deliver a central and dedicated website presence for all road safety teams to broadcast the work they do and have carried out.

The purpose of the website will be to:

Build an online presence that raises the profile of not just the road safety policy team but road safety as a whole.

The website should provide key information on the Road Safety Framework 2030, and provide information on the key priority areas – the 2030 is still in consultation but will be launched shortly after the website is live.

The remaining sections of the website will provide a variety of supporting content that increases the visibility of progress made towards those priorities in the form an evidence based approach.

Objectives

The overall project objectives have been summarise here, but are not limited to:

- 1. Ensure the websites users wants and needs are front and foremost.
- 2. Provide a seamless journey from the homepage of the RSS website to the dedicated policy website section.
- 3. Ensure continuity in the organisations name and branding are met.
- 4. Provide an online platform for all areas of TSRSP to broadcast all aspects of their work in a visual, engaging and transparent manner.
- 5. Provide a platform that is both scalable and easily updated by members of the TSRSP Policy team.
- 6. Continue to ensure online security, accessibility and usability compliance is achieved.

- Key Priorities (see opposite)
 - Age

It's key we try to present as much relevant and related information to user when they are on the website in order to create engagement, promote the variety of work the organisation commissions and also the shareability of the content to increase further awareness.
